- I. Mr. Shofler informed the board the net profit for the first seven months is \$37,030.18 which is \$25,760.26 more than our budgeted amount. He reported the TTHM & HAA5 testing is next month. Mr. Shofler also reported roof on Timber Hill Well is leaking.
